Coastal Adventures Summer Camp Information Packet

Coast Adventures is a field trip based adventure summer camp along the northern California coast dedicated to providing exploration activities that are educational, fun, and safe.

Our Facility

Our facility is located at **Upgrade Children's Center - 103 Harvard Ave, Half Moon Bay, CA 94019** in Princeton in the Pillar Point harbor area, close to Mavericks.

Transportation

We provide transportation to all our activities and adventures. Jon Lowings and his staff transport children to all adventures in two passenger vans. When driving, safety is taken very seriously. All children are properly seat belted and in appropriate booster seats, (if applicable). All vehicles are fully insured and drivers are trained by Jon.

Daily Schedule

Coastal Adventures has weekly themed activities - Water Week, Adventure Week, Beach Week and Park Week (see our site www.upgradechildrenscenter.com) for more details). However, the format of our daily schedule is the same for each week.

Hours

The program hours are **8:30am to 4pm**. After care is available until 5pm at the cost of \$10 per child/per day. Please notify us if you need after care.

Schedule

- **Gather at the Center (8:30am - 10:00am)**
Start of our day, meet at the center for art projects and active games. Kids get information on what the activity and plan will be for the day. We have the flexibility to choose where to go. If it's cold on the coast we leave to warmer weather. And if it's nice, we stick around since there's no better area for an adventure.
- **Our adventure begins! (10:00am)**
We leave for the day, usually going to one or two spots for our daily activities then head to a local park for a snack. Our vans are fully stocked with everything we need (wetsuits, boogie boards, games, etc.) no matter where we end up.
- **Lunch (12:00pm)**
Every child must bring his/her own lunch including beverage. Please send plenty of water or fluids for your child. We will provide an afternoon snack.
- **Return to Center (3:00pm)**
We return to the center to change our clothes, get a snack, play games and rest.
- **Pick Up (4:00pm)**
Pick up from the center. Parents must sign out children.

Important Information

Change of clothes

Remember, your child is here to have fun and should be appropriately dressed for recreational activities. During warm days your child may get wet. Please send your child with a bathing suit, towel, extra change of clothes, and outerwear. **Please mark all clothing items and equipment with your child's name.**

Sunscreen

Make sure your child has sunscreen (the higher SPF, the better) on their face and body before you drop them off. Children with skin sensitivities or allergies should bring their own sun protection.

Snack

An afternoon snack is provided. If you like, your child can bring his/her own snack. Please note on the emergency form if your child has any allergies or cannot eat certain foods.

Child Absence

If your child is going to be absent, you must let us know by 10:00am the day of their attendance. We have a very tight schedule of pick-ups. You can call Jon's cell # (650) 303-4055.

Discipline Policy

We have a zero tolerance discipline policy. You will be contacted if your child is bullying or showing poor behavior. In some cases, this may result in your child's removal from the camp.

Payment

Payment is \$375/week. All payments are due before or on the first day of the adventure week. Please make checks payable to “Coastal Adventures”.
